 - a. Pledges ahead of budget and ahead of last year; financial highlights shared & overall we are close to budget in most areas.
 - b. Investment committee report
 - i. \$516K in endowment:
 - ii. opened additional savings account account for funds not "owned" by board (Afghan, minister, AV fund and memorial garden fund);
 - iii. Investments decreased about 18% which is consistent with market overall.
- 9. Safety Bolar
 - a. Security walk through done & awaiting two quotes; first round of recommendations will be presented at April board meeting.

PLANNING FOR THE FUTURE

- 10. Policies under revision
 - a. Board Hampel, Bair, Lewis review and approve in April
 - b. Wage Structure Hunt
 - i. Per UUA salary recommendations we are \$50K short with salaries and ahead with benefits by 20%;
 - ii. Committee activities and analysis were reviewed in detail;
 - iii. UUA recommended strategy: "stair step/gradient" wage increases to "B" level in 2023 and "C" level in 2024; Board in agreement with this approach.
- 11. Planning for May, 2023 Annual Meeting Rev. Rachel
 - a. Annual meeting to be held Sunday, May 21;

- b. Format agreed upon: abbreviated service and then potluck celebration followed by business meeting ("theater style");
- c. Pre-meeting required for board to review and discuss budget;
